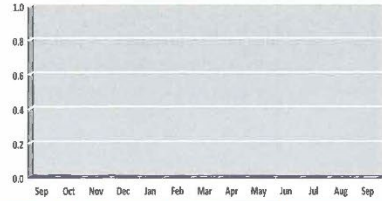

- **Water Billed** – Monthly Billed usage. Water is bought from the Pickens Water Authority.
- **Sewer Billed** – Monthly Billed usage. Sewer fee set from Pickens County Waste Treatment.
- **Sewer Surcharge** - Paid to Pickens County for Pump Stations & Treatment Centers owned by Pickens County.
- **Maintenance Fee** - Paid to the City for Replacement and Upkeep of Sewer lines within the City
- **Solid Waste** - Paid to the City for Residential expense of Trash Services
- **Brush / Brown Goods** - Paid to the City for the expense of removal of Brown Goods. (Leaves, Branches, Junk)
