Approval of Minutes -

1. February 13th, 2023, Regular Session

Motion: Councilmember Graybeal, Second: Councilmember Massie, No Discussion, Vote: unanimous 7-0

Old Business: (2nd Readings)-

1. 2nd Reading of 2023-02- Rezoning Oak Lane Ordinance from 501 to 501(a)

Mrs. Locke explained that this ordinance was for rezoning from (501) medium-density residential to (501a) medium-density and duplex density.

Motion: Councilmember Whitaker, second: Councilmember Padgett, Councilmember Padgett asked how many duplexes were going on that property. Mayor Woods replied with one duplex. Vote: unanimous 7-0

2. 2nd Reading of 2023-03- Amending Language in Manufactured Home Ordinance

Mrs. Locke explained that this ordinance was for amending the language for what is allowed for the exterior siding of a manufactured home.

Motion: Councilmember Shoenleben, Second: Councilmember Whitaker, No discussion, Vote: Unanimous 7-0

3. 2nd Reading of 2023-04- City Seal

Motion: Councilmember Massie, second: Councilmember Powell, Councilmember Graybeal asked if the City Seal could be tabled for citizens to interact in a public hearing. Mr. Calvert stated that it could no longer be tabled because it had already been motioned and second. It should have been brought before the council before the 2nd reading motion. Mr. Calvert also stated that the City Seal is for internal documentation, not typically brought before citizens. Still, the brand was brought before the citizens before being voted on. The vote was then taken 5-2 Councilmember Powell, Councilmember Whitaker, Councilmember Shoenleben, and Mayor Erica Woods - in favor. Councilmember Massie and Councilmember Graybeal -opposed it.
